Payment is due within ten days of invoice. Accounts shall be assessed 1.5% finance charge per month on past due balances, or 18% per annum. If collection is required, the customer agrees to pay all associated costs and attorneys fees.

Account applicants must have three business account references over twelve months old and ratings to qualify for an open account.

All accounts must charge a minimum of \$250.00 per year to remain active.

Accounts with past due balances of 45 days or more will be put on C.O.D. status.

Accounts remaining on C.O.D. status for 60 days or more may be closed at the discretion of the credit department.

Responsibility for payment within our credit terms rests with the person or firm to whom the account was granted. A customer's failure to collect money due is not an acceptable excuse for nonpayment with the terms agreed upon.

It is Diamond Rental Inc.'s policy to exercise its lien rights on all past due accounts.

Any change in a company's corporate structure or ownership will require a new application to be completed and submitted to our credit department.
